# St George's School on Mount Street Fundraising Activity

- Juliette Jackson provided update on St George's School fundraising activity. The school
  currently has 77 students out of capacity for 200. There are not enough children in Central
  London meaning many schools are under pressure to close.
- Provided St George's School can prove they are fundraising and increasing school children numbers, Westminster will not put pressure to close.
- Since September 2022, the school has raised £110,000. Need to raise £600,000 to keep open for three years.

- Caprice Group have two new licence applications: a century box outside Annabel's in Hays Mews and tables and chairs outside Bacchanalia, 1-3 Mount Street. MNF to object to both.
- Leconfield House application not yet submitted.
- P&PRC reviewed Terms of Reference and propose one minor change in relation to CIL obligations. This will come forward to Steering Group next month for approval.

# **Mount Street Piazza (CJ)**

• WCC support low level lighting on Mount Street Piazza. Support Mount Street Gardens pillars and gates improvement.

- Refresh of the website underway using internal Grosvenor resources. Ready to be shared with MNF early next week.
- Draft advert in Mayfair Times approved and to be used in wider communication channels to encourage members to join.
- Sign-up book to be organised at Mayfair Library and summer events.

# Park Lane (EW)

- A fundamental part of Mayfair Neighbourhood Plan. Architect Liam Hennessey has provided a plan to turn northboundcarriageway into two-way traffic lane and southbound into pedestrianised zone.
- NRP consultancy to look at traffic modelling and MNF provide support in writing paper.
   Endorsement from MNF for using NPR consultancy.
- **ACTION** NH and EW to make CIL application for £60,000 to WCC to improve Park Lane in order to start conversation with Westminster.
