Hanover Square Gardens – Underbelly Ltd

- Skate West is the proposed ice rink in Hanover Square from October – December 2023.
- Underbelly deliver high class high quality cultural events in city centre locations
- Ice rink on Hanover Square
- Supporting Great Ormond Street hospital with free tickets to be provided to families.
- Circular rink with bar in the centre. Toilet facilities
- Opening hours 10am – 10pm, 10am – 8pm. 24hour security to be located on site.
- Areas with ticketed access are 22-38% of total. 40% of the area must be kept accessible under MGS3.
- HVO generator reducing CO2 emission by 90%
- **ACTION** - DC to ensure Underbelly to share are drawings and calculations to confirm compliance
- MNF to accept support provided it fits within the size and provided it is for a one-year application.

Homelessness and Rough Sleeping Update

- More work needed to provide the level of detail required from MNF members.
- CO proposed question on whether MNF will support homeless scheme.

- Wider concerns over whether the homeless issue is too big and wide scoping for MNF.

- 67/68 Grosvenor Street – MNF comfortable on proposals
- 127 Mount Street – Further information needed on the operator of the restaurant
- 77 Park Lane new hotel – 130 room hotels, no concerns
- 8 Carlos Place – Memorandum of understanding to be explored with Grosvenor.
- Pushing for funding on Mayfair audit
- Park Lane – CIL application is running.

Communications and Marketing

- Ed has stepped down on communications so need to find replacement.

AOB

- EW raised concerns over increase in licenced premises in **Shepards Market**. There was an original premise that MNF do not get involved in licencing but since class E concerns are growing. 3am licencing more likely to be requires a separate meeting to move forward with plans on objections.
- **GDPR** issues ongoing with CCTV security projects by BEAM.
- **Chairman Role**, GM replacement encouraged from business members.
