1 Introduction and General Terms

Welcome to www.mayfairforum.org. This Privacy Notice sets out how we collect, use, disclose and transfer personal data that you may provide to the Mayfair Forum. Personal data is information which can identify you, such as your name and address. For the purposes of this Privacy Notice (unless expressly stated, or the context requires, otherwise), 'we', 'us' and 'our' refers to the Mayfair Forum.

Mayfair Forum is the data controller in respect of your personal information for the purposes of applicable data protection legislation.

2 Legal grounds for processing personal data

Mayfair Forum will process your personal data on the grounds that it is in our legitimate interest for the effective administration of the website. We also process data if you have given us your express consent such as for obtaining marketing services.

3 What personal information do we hold?

Mayfair Forum collects and processes personal information from you that may include: • First and last name, postal address, email address, telephone number and where appropriate, business name

4 How we collect this personal information

We collect information (including personal information) when you subscribe to the Mayfair Forum through the Website and entering into terms and conditions through this Website and/or when you submit requests, feedback forms or emails via this Website.

We will take appropriate measures to keep your information confidential and secure in accordance with our internal procedures covering the storage, access and disclosure of information.

Please note that messages you send to us by e-mail or via any internet connection may not be secure. If you choose to send any confidential information to us by such means you do so at your own risk with the knowledge that a third party may intercept this information and we do not accept any responsibility for the security or integrity of such information.

6 How long will we hold your personal information

We will only retain your personal information for as long as necessary to fulfil the purpose for which it was collected or to comply with legal, regulatory or internal policy requirements. However, if you wish to have your personal information removed from our databases, please contact us (see section 12). Subject to any legal or regulatory requirements, we will then remove this information.

7 Your rights

The accuracy of the information we hold about you is important to us. Under applicable data protection legislation, you have rights concerning your personal information.

• You have a right to correct any inaccurate or incomplete personal information we hold on you. You have a right to receive a copy of the personal information we hold on you, which we must provide to you in a structured, commonly-used and machine-readable format. You have a right to require us to stop or to restrict our processing of your personal information. You have a right to require the erasure of personal information we hold on you once it is no longer necessary in relation to the purposes for which the information was collected or is being processed. • Please contact us if you wish to exercise any of these rights.
